Preconference Workshops

Wednesday, May 27, 2026

8:00 AM - 5:00 PM **Student Assessment Workshop**

Students enter our EMS programs with the goal of becoming competent prehospital care providers. The EMS program has the responsibility to prepare students to be competent in the Cognitive, psychomotor, and affective domains and prepared to enter the profession. It is the program director who assumes responsibility for all aspects of the program, which includes appropriate student assessment. Student assessment should occur continually throughout the EMS program and occur in both the formative and summative realms.

This workshop will look at practices to help program directors and educators conduct student assessments in all domains of learning and discuss processes to help ensure the assessments are valid and reliable. Discussion will focus on cognitive assessment through discussion and written assessment, including test construction. Assessment of the psychomotor domain will look on scenario construction, using simulation as the assessment tool. The role of the affective domain will be emphasized as a component of both cognitive and psychomotor domains. The Clinical Judgement model will serve as the basis of the assessments.

8:00 AM - 5:00 PM **Integrating NAEMT Evidence-Based Courses into Your Paramedic Program**

The workshop will identify NAEMT course curricula that can be used to meet paramedic competency requirements, assist you in recognizing the process for incorporating NAEMT curricula into Paramedic initial education, and provide an opportunity to discuss best practices with program directors who have successfully incorporated NAEMT curricula into Paramedic education programs.

8:00 AM - 12:00 PM **Clinical Coordinator Workshop**

An AEMT or paramedic educational program may be tempted to focus extensively on the didactic and laboratory components and under-resource the clinical coordination components of the program. However, while students acquire the necessary knowledge and skills in the classroom and lab, the clinical rotations, field experience, and capstone field internship provide the opportunity to hone assessment and management techniques, further develop critical thinking abilities, and become competent patient care providers. This workshop will focus on expectations for the various clinical learning components, establishing expectations, assessing the quality of a clinical education site, evaluating students and sites, key elements of clinical coordination and supervision, and best practices in the capstone field internship. Participants are encouraged to bring issues they have encountered and address and the best practices from their program.

Each participant will submit items to a simulated item review panel, which will be conducted in the afternoon. The moderators will share all reviewed questions with each attendee, who will leave the session with increased item writing and review capabilities, plus quality questions ready to implement in their program examinations.

Medical directors play a key role in EMS education programs: approving the medical educational content, reviewing the instruments used to evaluate students, approving competencies required for graduation, and reviewing the progress of each student. These are the mechanics of the position. But how does a program develop and implement meaningful interaction between the medical director and the students? Between the medical director and the faculty? Medical directors often have limited time to devote to the program: how can the medical director and the program make the best use of that time? What activities are most effective? When should the medical director be involved in student selection, in observation of skill labs and simulations, in the classroom discussing didactic content or case presentations, in counseling of students, in final testing/evaluation, or in other activities? This presentation discusses approaches and best practices for engaging your medical director.

This session will explore how to effectively use advanced placement policies to grant students credit for prior education and experience, including how to ensure compliance with accreditation and certification requirements. Come learn how advanced placement may be utilized by your program to enhance paramedic workforce pathways.

Through real-world examples and actionable guidance, participants will leave better equipped to anticipate EA findings, address potential deficiencies proactively, and use the report as a tool for continual program improvement and site visit preparation.

The CAAHEP *Standards* identify distance education as a substantive change. What does this mean? What does my program have to do? What has changed? What are the requirements? What is even considered distance education? Is there additional approval required? Is there another cost involved? Distance delivery modalities can raise numerous questions for a program. This session will review the rationale for additional considerations when using a distance mode of delivery and detail what is required for effective implementation, operation, and monitoring. The implementation timeline and process will be discussed.

Room 2 – QI: Outcomes, Resources, Advisory Committee, & the Feedback Loop

Why are program outcomes an important consideration in evaluating a program? How are outcome thresholds established? How are program outcomes determined? What happens if a program continues to fall below the outcomes threshold? What is included in the resource assessment process, and what tools are programs required to use? Who participates in the resource assessment process? What other methods should we use to evaluate our program? What do we do with the information we gather from our outcomes and the resource assessment process? What role does the Advisory Committee play? The quality improvement process is ongoing and includes all the elements listed. This conversation addresses these questions and describes best practices in the quality improvement journey.

Like many states, Kentucky faced a significant paramedic workforce shortage with open positions far exceeding the number of graduates entering the profession. One paramedic education program responded with an innovative solution—building a network of CoAEMSP-approved alternate locations and harnessing synchronous distance education to bring high-quality instruction directly to students in their own communities. This session will showcase the design, implementation, and outcomes of this model, highlighting how it removed barriers, expanded access, and accelerated the pipeline of new paramedics. Attendees will gain insight into the considerations, technology infrastructure, faculty coordination, and partnerships necessary to replicate or adapt this approach to their own situation.

The work on exam creation doesn't stop once items are written. A rigorous and ongoing item analysis is important not only for exam quality and reliability but also for CoAEMSP. Room 2 – Case Study: AEMT Programs

On January 1, 2025, CAAHEP and CoAEMSP launched voluntary accreditation services for Advanced Emergency Medical Technician (AEMT) educational programs. North Carolina quickly became the first state to require AEMT programs to seek voluntary accreditation, and a South Carolina program became the first in the nation to obtain an AEMT Letter of Review. This session will explore their journeys through the accreditation process, offering attendees a case study in early adoption. Hear first-hand perspectives from the North Carolina Office of EMS and from a South Carolina program director who successfully navigated the application and review process. Attendees will gain practical insights into regulatory considerations, institutional challenges, and lessons learned that can help them prepare their own AEMT programs for accreditation.

Room 3 – Engaging Your Stakeholders & Communities of Interest

Who are the communities of interest for your program? Certainly, the program sponsor, but who else is impacted by your program and the graduates? EMS agency employers? Hospitals and other patient care providers that offer clinical sites? Agencies that provide field experience and capstone field internship? The program Advisory Committee? The program medical director? Other emergency responders such as law enforcement agencies? Other healthcare professions in your educational institution or the community? Local or state regulatory agencies? Students? Graduates? The public? The list of potential stakeholders can be long – and rich. This panel discussion will provide tips and strategies to engage those communities of interest.

Room 4 – Creating Reality on a Budget

You want to take your scenarios and simulations to the next level, but you have a very limited budget. What to do? A neighboring program boasts about their high dollar simulation equipment, and you are afraid that your students are missing out. Never fear, high dollar equipment does not necessarily make for high quality practice. The important component is making the scenario and simulation environments as realistic as possible – and that does not always take money. Start with determining the goals for the event and what would help the students suspend reality and engage. What are potential resources to create environments? Thrift shops, Craig's list, yard sales, faculty cast-offs? Where to get other supplies such as communication equipment? Are there potential locations such as an EMS vehicle, a budget motel, transporting to a hospital or clinic, or other venue. This session explores creative opportunities to enhance the student's experience.

Room 5 – Conversations with Site Visitors (invite only for current site visitors)

This session is designed to enhance the skills and knowledge of site visitors involved in accreditation reviews. Participants will receive updated guidance on evaluation criteria, best practices for conducting site visits, and strategies to provide constructive feedback. The session will include interactive activities and case studies to help site visitors apply what they learn in real accreditation settings.

Room 2 – Evaluating the Affective Domain

Historically, EMS education programs have emphasized the content, objectives, and evaluation of the cognitive and psychomotor domains: knowing what to do and how to do it. Considerably less emphasis has been given to evaluating the affective domain. And yet our behaviors, attitudes, motivation, and enthusiasm are what make us excellent providers. It is not enough to be a proficient technician; our patients deserve compassionate, professional care. Affect is also important in our interactions with colleagues and other stakeholders. Important traits are professionalism, communication, and ethical decision-making. Some programs are reluctant to evaluate students in the affective arena, fearing that observations and feedback can be too subjective. This presentation discusses the importance of robust evaluation and feedback on affective traits throughout the education program and methods to successfully help shape the successful provider.

Room 3 – Case Study: From Crisis to Success: Leading Change in a Troubled Accreditation Program

What happens when an EMS education program faces serious accreditation challenges? This session presents a real-world case study of a paramedic program that moved from crisis to success through focused leadership, collaboration, and intentional change. Attendees will explore the warning signs of a struggling program, the tough decisions leaders must make, and the strategies that turned the tide toward compliance and excellence. Through lessons learned, participants will gain practical tools for navigate their own program challenges, foster a culture of accountability, and lead teams through the often-difficult process of change. Whether you are a program director, dean, faculty member, or medical director, this session will provide insights into sustaining accreditation while strengthening your program's foundation for long-term success.

Room 4 – Satellites, Alternate Locations, and Outsourcing

As EMS education programs expand to meet community and workforce needs, questions often arise about the use of satellite campuses, alternate locations, and outsourcing arrangements. This session will provide clarity on the requirements and expectations outlined in the CAAHEP Standards and CoAEMSP policy. Participants will gain an understanding of the definitions, distinctions, and approval processes related to these structures, as well as the documentation and reporting obligations that accompany them. Real-world scenarios will illustrate how programs can maintain compliance while ensuring high-quality student experiences across multiple sites. Whether you are part of an established CAAHEP-accredited program or operating under a CoAEMSP Letter of Review, this session will equip you with the knowledge to make informed decisions about program expansion.

Summative evaluation can take a variety of forms. Depending on the program structure, summative evaluation in the cognitive, psychomotor, and affective domains may occur at the conclusion of each chapter, at the conclusion of each module, at the end of each semester, or at other established milestones. Cognitive evaluations at these points are typically referred to as high-stakes exams, meaning that the student must be successful in proceeding in the course. A final, summative, comprehensive evaluation is required by the CAAHEP Standards as follows: “Achievement of the program competencies required for graduation must be assessed by criterion-referenced, summative, comprehensive final evaluations in all learning domains at the completion of the program.” The Interpretations of the Standards further clarifies: “Summative program evaluation is a capstone event that occurs when the capstone field internship is at or near completion”. This presentation discusses the rationale and best practices for developing and implementing this final summative evaluation.

This year, roughly 25% of program directors will embrace the standards of accreditation for the first time. They will, like many of us did, cut and paste, copy and transcribe, borrow and replace all in the interest of meeting minimum standards and achieving accreditation. But program goals and expectations are an opportunity to frame the future of EMS. We as program directors have the unique opportunity to conceive tomorrow's practitioners and leverage their capabilities to evolve our profession. How do we therefore build programs that match standards but also envision new processes, better procedures, and higher expectations. The short answer is that we loosen the binds of program directors and unleash the collective creativity of nearly 700 minds. In other words, we envision a system where accreditation stops holding us back and starts moving forward. Please join us as we discuss this path forward.
